

Fiscal Year 2027* NAPEBT Wellness Incentive Program

*Points are earned in Fiscal year 2027 (May 16, 2026 to May 15, 2027) and received in Fiscal year 2028 (July 1, 2027 to June 30, 2028).

The Health Plan Incentive (Step 1) is \$240 Health Plan Discount for completing an annual physical.

The Personal Wellness Incentive (Step 2) is \$240 for redeeming 1200 wellness points in the My Vera Reward Center.

Step 1 must be completed to be eligible for Step 2.

Complete (and attest to completing) the following activities between May 16, 2026 and May 15, 2027.
